I WENT BY PLANTER CAMP 0736. WILFRED SAID IT WOULD BE 20 MIN. BEFORE THEY WERE READY. I SAID FINE - I WANTED TO UNLOAD MY AND LOAD TRUCK. WE LEFT AROUND 0835. I HAD TO HIRE SOME BAGS. CREW WALKED TO 1.9 TO MEET ME TO UNIT. BAGGED UP AT 1.9 - TOOK ALL TRUCK TO BOTTOM OF UNIT AND CACHED THEM. I ASKED WILFRED TO GO OVER GROUNDLINE/ADDC. HE DID SO WITH CREW. I TOLD HIM DEATH, SPACING Y ROUTE WERE IMPORTANT TODAY. SPACING WAS TIGHT - TOO TIGHT. I HAD PEOPLE UNLOAD MY. CREW LOOKS BETTER THIS AM W/ Y LEFT IN CAMP. JOB OVERALL LOOKS BETTER. STILL SOMEWHAT DISORGANIZED IN TERMS OF FOLLOWING LINES Y BACH OTHER. THERE I AM LOOKED GOOD. DEATH LOOKS OK. STILL A LOT OF STANDING AROUND I HAD SUGGESTION YESTERDAY THAT WILFRED CARRY A HAD TO

5. NARRATIVE REPORT (continued from 6300-20)

AIR & REPLANT Y AS MONEY RATE TO CROW.

I ASKED WILFERDO TO GIVE ME A LITTLE LEAD TIME IF CROW LOOKED LIKE IT WAS GOING TO RUN OUT OF TREES BEFORE UNIT WAS DONE. HE THOUGHT NOT A PROBLEM. IT OBVIOUSLY BECAME A PROBLEM AND I LEFT FOR MORE TREES. SWEETBAC MEN OUT OF TREES THAT JUST STANDING AROUND. I WAS GONE PERHAPS 20 MIN. ONLY ONE MAN WAS DOWN AT APU TO HELP ME BACK TREES TO UNIT. WE EACH TOOK 250. I DISTRIBUTED TREES TO TWO STOPS WAITING AT BOTTOM OF UNIT. I WENT AND TOLD WILFERDO THAT TREES WERE COMING. MORE FOLKS JUST STANDING AROUND. I ASKED WILFERDO TO DISTRIBUTE TREES. NOT MUCH HAPPENED. I PASSED TREES OUT AND STILL PEOPLE STANDING AROUND. I FINALLY SCREAMED AT WILFERDO TO "NOT TAKE 15 MIN. DISCUSSION ABOUT IT, JUST PLANT 'GOD DAMNED THINGS'". HE WAS SOMEWHAT TAKEN ABACK. CROW STARTED PLANTING. ANOTHER 500 TREES WERE BROUGHT UP BUT NOT ALREADY.

MARK SAID HE WAS ONE BUNCH OF US ON LEAD GUY - ALL BLAZING S-ROOPE. THE MAN WAS SENT TO UAN UNIT DONE 1420. CROW AT UAN 1440.

I TOLD WILFERDO WE COULD JUST LEAVE TO GO TO 2ND UNIT JUST DOWN ROAD. I LEFT APU AND PROCEEDED TO 1.6. CROW TOOK 20 MIN BREAK FOR LUNCH.

I BRIEFED WILFERDO ON UNIT, SIZE, ACCEPTABLE TREES. ANOTHER MAN SHOWED UP TO PLANT. WILFERDO WANTED MY NAME I SAID NO. HE SENT S-ROOPE TO CAMP TO GET A HORSE I SAID GUY COULD PLANT IF HE WAS GOING TO PLANT GOOD BUNCH. WILFERDO SAID HE HAD TALKED TO GUY AND HE SAID HE WOULD DO A GOOD JOB.

CROW STARTED IN SPACING TIGHT. MICROFILM & BIRTH OK.

MARK SHOWED UP, TOOK BUNCH LUNCH AND CAME DOWN ON UNIT. I MET 1630.

JOB LOOKS BETTER THAN FIRST DAY. I TOLD WILFERDO PRODUCTION IS AN ISSUE - SHOULD BE GETTING 10-12 A/DAY. I ASKED FOR 12 MEN ON SUN IF POSSIBLE BUT TOLD HIM NOT TO BRING FOLKS THAT DIDN'T WANT TO BE HERE.
